Adoption of Agenda

Motion: To adopt the agenda by Dawn Dize and seconded by Susan Rillo. Roll Call Vote: Bliss=yes; Dize -yes; Hart=yes; Finney=yes; Rillo=yes; Zember- yes. MOTION PASSED

CD Maturing at BB&T Bank on 8/11/2017 (\$125,766.27)

Ms. Salazar presented Council with a sheet of current rates. A copy will be attached to the minutes.

Motion: To purchase a 26-month CD at Suntrust Bank in the amount of \$125,766.27 with an interest rate of 1.35% by Susan Rillo and seconded by Ned Finney. Roll Call Vote: Bliss=yes; Dize -yes; Hart=yes; Finney=yes; Rillo=yes; Zember- yes. MOTION PASSED

Property at 25571 E. Main Street

Ms. Salazar reminded the Council that any changes made to the current schematic plan will be at an additional cost to the Town. There was some discussion about whether or not to keep the cupola/ clock on the façade of the building. Some members were in favor of and some against mainly due to the costs associated with both.

Motion: To adopt the current schematic plan leaving in the cupola/clock as an option depending upon the actual costs by Ned Finney and seconded by Susan Rillo. Roll Call Vote: Bliss=yes; Dize -yes; Hart-no; Finney=yes; Rillo=yes; Zember- yes. MOTION PASSED

Mr. Hart stated that he voted no because he is opposed to the building being built on a concrete slab. He thinks the building needs to be elevated due to concerns with flooding.
