Greetings from the Onley Police Department. We hope that everyone had a safe July 4th.

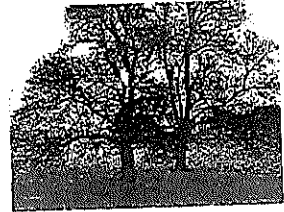
As you are aware, traffic on Route 13 increases tremendously throughout the summer so please be aware & use caution when driving.

## Burning in Onley

The Town of Onley is covered under Accomack County's Open Burning Ordinance.

Some things to remember when burning in Town:

- All fires must be attended at all times
- A water hose & fire extinguisher must be readily available at all times
- All neighbors within 300 feet must be notified for permission
- Notify the 911 center of your controlled burn at 787-0911
- Only yard debris may be burned—no tires, paint or chemicals

**Swimming Pools deeper than 48" require a 5' high fence**

**Grass Height Shall be no more than 7"**

**Please do not blow your grass clippings into the street**

## A Message from the Treasurer

A friendly reminder to all that 2012 Real Estate and Personal Property taxes were due in December - any not paid at this time are subject to a penalty and interest.

2013 Business Licenses were due before March 1, 2013 so please see me if

you are in need of one. Decals went on sale March 15, 2013 and you will be required to bring a current registration for each vehicle/trailer for which a decal is being purchased.

Please remember that while trash pickup is normally on Tuesday, in MOST cases if

there is a Monday holiday—trash pickup will be on Wednesday that week only.
